East County Fire and Rescue is conducting a recruitment process in order to establish an eligibility list to fill future Part-time Firefighter/EMT positions.

Salary Range: \$12.50 - \$16.00 per hour DOQ

Open Period: Accepting continuous applications

Position Information: Part-Time

Hours of Employment: 0700-0700 on a scheduled A, B, or C shift. Every sixth day.

**Benefits:** East County Fire & Rescue provides employees with benefits including, but not limited to, Public Employee Retirement System (PERS), employee assistance program; Personal Time Off program; and training opportunities.

**Examples of Duties:** Part time Firefighter / EMT performs daily station duties to include equipment and facilities maintenance, daily fire and medical training, and provide public information and assistance. Responsibilities also include incident response, apparatus operation, report writing and fire ground operations.

- HAZMAT Awareness Certified (must obtain HAZMAT OPS cert within 6 months of hire date)
- Emergency Vehicle Incident Prevention Certified (or equivalent)
- Authorized to work in the US
- Proof of current CPAT certification (within previous 12 months)

- HAZMAT OPS Certified

- IFSAC Firefighter I, II

There will be no written exam. All qualified applications will be held until a part-time opening occurs. At that time East Co. Fire and Rescue will schedule Chief interviews for as many applicants as necessary for the number of job openings.

Upon conditional offer of employment, a background investigation will be conducted and will consist of a comprehensive investigation of your education and employment history (including a criminal and DMV review), drug screening, and a medical examination.
